## **PURPOSE OF USE**

BeautyRelax SteamMax Professional is an innovative device for skin treatment using atomized steam. The steam molecules are smaller in size than the diameter of the skin pores. The mask delivers the beneficial effects of steam evenly over the entire facial area. Facial muscles are relaxed, skin is warmed and skin pores are opened. The subsequent cleansing process and other skin care methods are multiply effective. The skin is supple and hydrated. The steam temperature can be regulated. Function settings via remote control. 4 skin treatment modes. Quick pre-heating. Steam is generated after just 1 minute. Produces 9g of steam per minute. Mask easily adapts to each user. Integrated water reservoir.


## **DESCRIPTION OF THE CONTROLLER**

- 1. Display
- 2. MODE A button
- 3. MODE button B
- 4. MODE button C
- 5. MODE D button
- **6. TEMP +** button (temperature increase)
- **7. TEMP** button (temperature reduction)
- **8. T+** button (time increase)
- **9. T** (temperature reduction) button
- 10. ON/OFF button



## **DISPLAY DESCRIPTION**

- 1. Steam temperature (degrees Celsius)
- 2. Timer (in minutes)
- 3. Mode indication
- **4.** Steam preheating indication



## **CONTROL OF THE DEVICE**

1. Connect the power adapter connector to the cable. Plug the connector into the socket and twist the connector. This secures the cable so that it cannot become disconnected during use.



- **2.** Remove the reservoir cap at the top of the unit.
- **3.** Fill the reservoir with distilled water. In the long run, this will contribute to the longevity of the instrument. The tap water may contain limescale particles, which is technically not acceptable for the instrument.
- **4.** Plug the AC adaptor into an electrical outlet. Always make sure there is no moisture on your hands.
- **5.** To switch on the device, press the **ON/OFF** button.
- **6.** Use the TEMP+ and TEMP- buttons to adjust the steam temperature. The available values are 35°C, 40°C, 45°C, 50°C, 55°C and 60°C.
- 7. Use the T+ and T- buttons to set the time of use. Values from 1 to 60 minutes are available.
- 8. Use the MODE A B C D buttons to set the steam dosing programme. There are intervals of 5 seconds (MODE A), 10 seconds (MODE B), 20 seconds (MODE C) and 30 seconds (MODE D).
- **9.** The progress of the preheating is shown by the icon in the bottom right corner of the display. The preheating process is accompanied by a flashing icon.
- **10.** You can switch the device off at any time using the **ON/OFF** button.

## **NOTES ON THE USE OF THE DEVICE**

- **1.** Do not pull the device too tightly to your face. On the other hand, the mask should be in full contact with your face.
- 2. If you are just getting to know the machine, we recommend setting lower steam values. Add gradually according to your feeling. The steam should feel comfortable on your face. It should not burn the surface of your skin.
- **3.** The optimal timing of use is when you need further work on your skin (deep cleansing, skin lifting, etc.). You can also use the device regularly for active relaxation and facial relaxation. You will achieve a pleasant relaxation of the facial muscles.
- **4.** The use of the device is beneficial for your skin in winter, when the skin often suffers from dehydration. Similarly, it is very beneficial to use during the summer months, when the skin is dry from the sun.
- **5.** At lower steam temperatures, you actively hydrate your skin. At higher steam temperatures, you help open the pores. Your skin is then perfectly prepared for the next facial treatment.
- **6.** The recommended time of use is for guidance only. Begin use at shorter intervals. Gradually increase the time according to your feeling.
- **7.** If you use the device in winter, wait until your skin has cooled down after using the device. With warmed skin, you should not go immediately in very cold temperatures that are close to freezing.
- **8.** The steam gradually condenses on the skin during the treatment. Therefore, the design of the device is such that this liquid is trapped in the lower rim between the face and the device. However, we still recommend that a cosmetic tissue is kept in hand during use to wipe off any water that would run downward from the neck.
- **9.** Always keep the surface of your hands dry when handling the AC adapter. Otherwise, there is a risk of electric shock.
- **10.** The device has no eye ports. Therefore, first set the application parameters on the controller and then apply the device to the face.
- **11.** Use the device only with distilled or baby water. This will help to maintain the longevity and proper functionality of the instrument in the long run.
- **12.** Do not add any other substances, dyes or aormats to the reservoir. Serious and permanent damage to the instrument could occur.

## **CLEANING AND MAINTENANCE**

Always ensure that the area of the device that is in contact with your face is cleaned after use. This is especially true if more than one person is using the device, in order to comply with the principles of hygiene. In this case, it is ideal to disinfect the surface of the contact area. Optimally with an alcohol spray solution. Do not use any aggressive cleaning agents. Moisture must NEVER penetrate the device. After use, dry the instrument thoroughly with a soft cloth.
