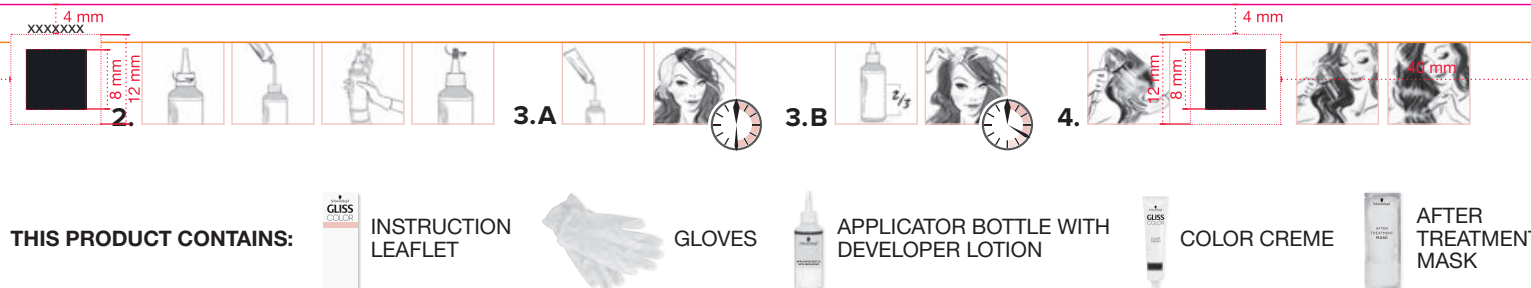

ATTENTION, PLEASE NOTE

Before application, please read the safety instructions on the back side of the instruction leaflet carefully.

1. PREPARATION

Before starting the application, place a **clothing protection** and a **watch** nearby so that you can monitor the application time.

Gliss Color is to be used on dry, not pre-washed hair.

2. MIXING

Unscrew the cap of the Applicator bottle with developer. Put the gloves on. Open the Color Creme Tube by piercing the tube sealing with the reverse side of the cap.

Squeeze the **whole** content of Color Creme Tube into the Applicator bottle. Close the Applicator bottle again and **shake** it vigorously until all components are thoroughly mixed and turned into a homogeneous creme.

Finally, unscrew the upper cap and start with the application **immediately**.

ATTENTION: The color of the mixture changes during the application process. This has no impact on color result.

3. A TOTAL APPLICATION

This application is recommended if you are coloring your hair permanently for the first time, or your previous hair color has totally grown out, i.e. no regrowth can be seen.

Starting from the back of your head to the front, apply the prepared coloration mixture strand after strand on your whole hair. Then distribute the mixture into the hair. Remove color stain on the skin immediately.

Leave the mixture for **30 minutes**.

For shades 9-1, 10-1, 10-2, 10-4 and 10-55: Allow the coloration mixture to work for **45 minutes**.

3. B REGROWTH APPLICATION

This method is recommended if your hair is colored and the regrowth is visible, or if the ends of your hair are darker or in poor condition.

For this, make a parting with the tip of the Applicator bottle. Apply about $\frac{2}{3}$ of the coloration mixture only on the regrowth area. Apply the mixture along the parting by distributing it into the roots with your fingertips (leave supplied gloves on). Repeat this procedure for the whole regrowth area. Allow the coloration mixture to work for **20 minutes**.

Apply the rest of the mixture to the whole hair and allow it to work for a further **10 minutes**.

For shades 9-1, 10-1, 10-2, 10-4 and 10-55: Apply to the roots area only and allow the coloration mixture to work for **35 minutes**. Apply the rest for max. **10 minutes** in the rest of the hair.

4. RINSE & AFTER TREATMENT

Before rinsing your hair, put on gloves again. Rinse the hair well at the end of processing time with lukewarm water until water runs clear.

As a subsequent care, apply the Mask into the wet hair. Allow the Mask to work for **2 minutes** and then rinse out thoroughly. After application of the Mask your hair is easy to comb, soft and full of shine.

HELPFUL HINTS

You can use a lipbalm to protect your forehead skin from color stains.

For hair longer than chin length, we recommend to use two packs. Leave at least 2 weeks between coloring and applying a perm/straightening treatment to your hair, otherwise the color result could become uneven.

If your hair is bleached, straighted, sun exposed or permed, we recommend reducing the processing time about **5-10 minutes**.

SAFETY INSTRUCTIONS

 Hair colorants can cause severe allergic reactions.

Read and follow instructions. This product is not intended for use on persons under the age of 16. Temporary “black henna” tattoos may increase your risk of allergy.

Do not colour your hair if:

- you have a rash on your face or sensitive, irritated and damaged scalp,
- you have ever experienced any reaction after colouring your hair,
- you have experienced a reaction to a temporary “black henna” tattoo in the past.

Do not use to dye eyelashes or eyebrows. Contains: see folding box. Rinse hair well after application. Avoid contact with eyes. Rinse immediately if product comes into contact with them. Wear suitable gloves. Keep out of reach of children. Keep the empty carton and the instruction leaflet in case you experience a reaction. To reduce your risk follow these instructions.

1. ALLERGY ALERT TEST

Perform an allergy alert test 48 hours before each product use even if you have already used colouring products before. Perform the allergy alert test on an area of skin sized approximately 1 cm x 1 cm on the inside of the elbow. Apply a small amount of the Color Creme in a thin layer on the inside of the elbow with a cotton bud and leave uncovered for 45 minutes. Avoid contact with clothes. Close tube again carefully. After 45 minutes, wash off the Color Creme thoroughly with lukewarm water. If any reaction occurs during the processing time or during the following 48 hours, you should rinse immediately and not use this colorant. This test represents an important precaution. However, be aware that even if an allergy alert test has been carried out you may still experience an allergic reaction when you colour your hair. The allergy alert test is not a guarantee of avoiding future allergic reactions. Please consult a doctor, if you have any doubts.

2. IF DURING COLOURING YOU EXPERIENCE

- any stinging or burning and/or rash, rinse immediately and discontinue colouring your hair as this may be an indication of a more serious reaction. Do not colour your hair again before consulting a doctor or seeking medical advice.
- rapidly spreading skin rash, dizziness or faintness, shortness of breath and/or swelling of eyes/face, rinse immediately and seek immediate medical attention and contact the manufacturer.

3. IF AFTER COLOURING OR ON THE FOLLOWING DAYS YOU EXPERIENCE problems such as skin or scalp itching, skin or scalp rash, swelling of eyes/face, blistering and/or skin or scalp weeping, seek immediate medical attention and contact the manufacturer.

PRECAUTIONS

- This product contains ingredients which may cause severe eye irritation and possible permanent eye injury. If the developer or hair colour mixture gets into your eye, flush immediately with a large amount of lukewarm water and seek medical advice.
- If you wear contact lenses during application and any product gets into your eye, remove the contact lens first, then flush immediately with a large amount of lukewarm water and seek medical advice.
- Do not inhale or ingest the product.
- Avoid unnecessary skin contact.
- Do not use if your hair has been coloured with henna or metal dyes.
- Remove all metal objects such as clips and hair pins from hair before colouring and keep them away during colouring. Do not use metal tools.
- Keep developer away from heat and light. Do not mix this colorant with any other products. Do not keep any unused product. Do not leave the mixture in a closed bottle (bottle may expand or burst).









